Irene Antol, 121 E. Mifflin Street, she would like to have clarified the motion that was passed, which she is not against, but would like to know what for the Fire Tax is for; what does special purposes, equipment & firehouses mean. The solicitor, Gina stated it is mainly for the operation and maintenance of firehouses, certain special purposes under the borough code that you can pass a special tax for and firehouses and maintenance fall under that. Then Irene asked what is firehouse maintenance, she asked is it their utilities, their upkeep or what. Mike Bogesdorfer replied, like paving their driveway, everything like that, practically for everything. Secretary Lippert stated if they needed a new roof, new plumbing electrical, Gina stated new equipment, another council person stated new garage doors. Irene state then it is for equipment or repairs, not for them to use. Mike stated equipment yes, if they need equipment they can go buy it. Irene understands equipment but it says firehouses, is that the maintenance of the firehouse, or is that paying their utility bills or what? Since she paid the tax, she wants to know. Mike stated it is to take care of the whole thing really, maintenance and all that, whatever they need up there. Irene asked so the utility bills are included in that? Mike stated yep. Several others were heard stating that is should not include utilities. Irene stated they don't o any fund raising other than the hoagies and they do not have enough members to fund raise, they need the money to pay their bills then...Mike stated yes, she said thank you.
