CITIZEN'S PARTICIPATION

David Madjerich - 146 Hamilton Street - Wanted to thank council for what they do for the borough. He complimented Dan Urban for the Walk of Honor that will be happening at the Memorial Day Parade and that he will be spreading the word regarding this recognition for veterans. He stated he hopes that someone from council will be overseeing the construction of the new DPW Building, he was assured that it will be overseen as we have 2 engineers on council that are involved in the project. He mentioned the Dumpster Ordinance, was not sure what it was about and he was told it is amending the existing Ordinance. He stated he has not seen a police presence in the borough for a while, council replied it has been hard to find officers to which Mr. Madjerich stated he understood. Then he stated with the county's tax increase that he felt the borough should let the county know that as a borough we did not agree their decision to raise the taxes.

Christine Teck – 230 Sherman Street – She wanted council to know that she is not able to get to the side of the house to maintain the weeds that grow up the house and around her air conditioner because the neighbor located at 226 Sherman Street still has not removed a tree that fell last year. She stated that her landlord paid last year to get the tree cut up and it was stacked neatly on her side, but it is still there.

Ken Mack – 171 Grant Avenue - Wanted to know if the borough was aware of wires down at 233 Cedar, Al Race replied that the borough is aware and that the company has been called numerous times.
